

Consent of the data subject (person concerned) to the processing of personal data

In the event that you indicate your consent to the provision and processing of the said personal data, you confirm that in accordance with and within the scope of Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of private individuals in the processing of personal data and on the free movement of such data, repealing the directive 95/46/EC (general regulation on the protection of personal data, hereinafter referred to as the "GDPR Regulation") you were provided information by the operator about the processing of personal data, that you have been informed about the rights and obligations of the data subject and that you agree with processing of your personal data: name, surname, company, e-mail address (hereinafter referred to as "personal data") by the operator:

Company Irbis Group, s.r.o with its registered office at Gogoľova 18 4, 851 01 Bratislava, Company ID No.: 36810436 (hereinafter referred to as the "operator"), for the purpose of: **establishing contact and marketing activities (sending direct mails, newsletters, displaying paid advertising on social networks Facebook, Instagram, the YouTube portal and in Google search), namely information on competitions, events organized as part of Green Talk's activities.** Consent applies to all processing activities performed with personal data for the same purpose.

The data subject grants consent to the processing of personal data for a period of 5 years from the granting of consent. Following the expiration of the above-mentioned period, the operator shall immediately destroy (delete) the provided personal data from the operator's information systems. This does not apply if the data subject has exercised his/her right to erasure pursuant to Art. 17 of the GDPR Regulation.

Consent can be revoked at any time in writing at the address of the Operator or by sending an e-mail to the address office@irbisgroup.sk

Under the conditions set out in the GDPR Regulation, the data subject has the right to request from the operator access to personal data relating to the data subject and the right to their correction or deletion or restriction of processing, or the right to object to processing, as well as the right to data portability.

The operator has a designated person responsible for the protection of personal data, whom the data subject can contact in connection with all questions related to the processing of his personal data and the exercise of his rights under the GDPR Regulation; contact information for the designated person of the operator: e-mail: office@irbisgroup.sk or in writing to the Operator's address with marking: "GDPR officer".

The data subject acknowledges that his/her personal data may be provided to recipients such as **[SmartSelling a.s.]**.

The operator does not publish the data subject's personal data and does not transfer them to third countries.



If the data subject believes that the processing of personal data concerning him/her is in violation of the GDPR Regulation, he/she can file a complaint with the Personal Data Protection Office of the Slovak Republic, Hraničná 12, 820 07 Bratislava 27, tel. +421 /2/ 3231 3214, e-mail: statny.dozor@pdp.gov.sk or at another supervisory authority in accordance with Article 77 of the GDPR Regulation.

The data subject confirms that he/she provided personal data voluntarily, without coercion, that they are true and that he/she agrees to their use for the defined purpose.
